豁免法律責任條款

Waiver and Release Agreement

本人同意 1) 參加新唐人電視台第五屆「全世界中國舞舞蹈大賽」(以下簡稱「大賽」)不可能排除有受傷的危險。2) 參加「大賽」的條件之一是本人將放棄向主辦團體以及他們的雇員、大賽機構、主管人員、經理以及教練(以下簡稱「受保機構」)對參賽中本人可能遭到的意外傷害或損失提出索賠。本人同意在參賽期間,如有損壞比賽場地,本人將承擔所有責任。3) 根據此「豁免法律責任條款」(以下簡稱「條款」),本人將永遠放棄、解除和豁免所有因為參加本次「大賽」而引起的法律糾紛和訴訟,無論是已經發生或將要發生的、已知或未知的。4) 簽署此條款,本人將承擔所有參賽的風險。

I hereby acknowledge and agree that: (i) there are risks inherent in participating in *NTD Television Fifth International Classical Chinese Dance Competition* (the "Competition"); (ii) in order for me to be allowed to participate in the Competition, I give up my rights to hold the organizers, and their employees, agents, officers, directors, and instructors (the "Covered Entities") liable for any injury or damage that I may suffer while participating in the Competition, I will also be liable for any damage to the venue, if any, caused by my performance; (iii) this Waiver and Release Agreement (the "Agreement") will release, discharge, waive and forever relinquish any and all actions, causes of action and claims that I have, may have or have had, whether past, present or future, whether known or unknown, and whether anticipated or unanticipated by me, arising out of participation in the Competition; and (iv) by signing this Agreement, I am assuming full responsibility for any and all risk while participating in the Competition.

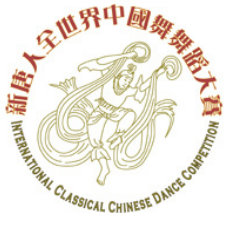

赴美參賽簽證指南

- 1) 通常您的護照需要有效期在來美 6 個月之內不失效。
- 2) 以下只是大體規則，細節請參閱 http://travel.state.gov/visa/visa_1750.html
 - 若您已有入境美國簽證或官方認可證件，無須為「全世界中國舞舞蹈大賽」單獨申請簽證。
 - 持以下 27 個“免簽國/地區”護照者可以無須簽證登陸美國⁴。
Andorra, Australia, Austria, Belgium, Brunei, Denmark, Finland, France, Germany, Iceland, Ireland, Italy, Japan, Liechtenstein, Luxembourg, Monaco, the Netherlands, New Zealand, Norway, Portugal, San Marino, Singapore, Slovenia, Spain, Sweden, Switzerland, United Kingdom
(安道爾、奧地利、澳大利亞、比利時、文萊、丹麥、芬蘭、法國、德國、冰島、愛爾蘭、意大利、日本、列支敦士登、盧森堡、摩納哥、荷蘭、新西蘭、挪威、葡萄牙、聖瑪力諾、新加坡、斯洛文尼亞、西班牙、瑞典、瑞士和英國)
- 3) 加拿大及百慕大公民來美參賽通常無須簽證。
- 4) 其它國家/地區公民須辦理入美簽證。通常可辦理訪問簽證(B 簽證)。報名參賽者可與我們聯絡，獲取大賽邀請函。各國訪問簽證等候期長短不同。參賽者請盡快與最近的美國使領館聯絡辦理簽證事宜。

⁴ 以上 27 國免簽合法居留期為 90 天以內，來訪者必須持有机讀護照(Machine-readable passport)，不符合此條件者仍需赴美使領館辦理簽證。
